

Poverty Among Colorado Families, Kids Remains High as U.S. House Prepares to Slash a Critical Lifeline September 19, 2013

On the day the U.S. House of Representatives is scheduled to debate drastic cuts to the Supplemental Nutrition Assistance Program(SNAP), hundreds of thousands of struggling Coloradans are still living in poverty and need food assistance to survive, according to new U.S. Census Bureau data.

In 2012 there were 694,842 Coloradans – or 13.7 percent – living in poverty, the Census report shows. Tragically, over 18 percent of Colorado's children were living in poverty last year, much higher than at the start of the recession in 2007, when it was 15.9 percent.

In Colorado, 186,217 households relied on SNAP (formerly known as food stamps) to put food on the table last year, according to the new American Community Survey Census data. That was roughly 9.3 percent of all Colorado households. Among these struggling families are:

- *Seniors:* 21 percent of households had at least one senior over the age of 60.
- *Children:* 56 percent of households had at least one child under the age of 18.
- **People with Disabilities:** 41 percent of households had a person with a disability.
- *Workers:* 82 percent of households had at least one worker, while 32 percent had two or more.

Each of Colorado's seven Congressional districts showed continued elevated rates of child and family poverty and unemployment, according to the Census data. See Table 1.

Now is not the time for cuts to a vital work support like SNAP that is helping families across Colorado get back on their feet. Colorado's Congressional delegation should vote "No." Contact your U.S. Representatives today and tell them to oppose HR 3102, the Nutrition Reform Work Opportunity Act of 2013, which cuts \$40 billion from the SNAP program and will leave tens of thousands of Coloradans hungry.
